- Supporting school reform and academic excellence at the primary and secondary school levels, including the [South Loop Elementary School](#) and [Namaste Charter School](#).
- Providing *pro bono* service to the Young Professionals Board for Open Heart Magic, a Chicago-based organization that trains and staffs magicians at local hospitals.

The firm has participated in [The Salvation Army's "Adopt-A-Family" Program](#), which provides gifts and donations to needy families during the holiday season.
